DCYO was started by Roseburg music teacher Jean Hinkle with five students in 1997. Currently, DCYO enrolls between 60 and 70, where students learn note reading, hone their technique, refine their listening strategies, and develop their performance experience through diverse repertoire from Mozart to movie music. DCYO students learn through collaborations with professional musicians from the Eugene Symphony Orchestra, and enjoy free, grant-funded private lessons with our teachers, many of whom have advanced music degrees.
